Childcare subsidy application for 2023 (Application due January 31st, 2024)

GSOC-UAW Local 2110 and New York University are pleased to announce a childcare subsidy program has been created for eligible GSOC-UAW graduate employees. The childcare subsidy program grew to \$225,000 in 2023 and is apportioned based upon the number of eligible applicants.

The subsidy is available to those graduate student employees who meet all of the following eligibility criteria:

- Must have held a GSOC-UAW Local 2110 bargaining unit position in calendar year 2023.
- Must be a parent or guardian of one or more children.
- Must have expenses associated with the childcare of one or more children.

To apply, please fill out this form and attach:

- 1. a copy of your appointment letter for one semester of work in a Union position in 2023;
- 2. proof of birth, such as a copy of your child's birth certificate;
- 3. the attached affidavit, signed, proving your guardianship of the child.

Union positions are defined by Article I of our contract and include:

- Graduate students (Master's/Ph.D.) who teach classes or have appointed teaching assistantships or laboratory assistantships (except Ph.D. student adjuncts beyond the 7th year and MBA candidates at Stern)
 - Appointed Ph.D. research assistants (with exceptions at Tandon and GSAS sciences)
 - **Graduate & Course Assistants** (with exceptions at the School of Medicine)
 - Graduate student workers in a range of miscellaneous positions, who are employed by NYU
